Parking: this issue was raised with reference in particular to a car which is regularly parked just to the Sturry side of the bridge. FTC is making representations to CCC on this matter. The annual CCC review of parking restrictions is in February.

84/19 To receive reports from CCC and KCC representatives

For KCC, Alan Marsh was dismayed to discover that James Brokenshire MP had just left his ministerial post.

For CCC, Mrs Glover reported that the Goose Farm planning application has been rejected. The result of the judicial review of the Hoplands development is imminent.

Waste services are soon to be no longer contracted to SERCO but will be run "in house". The same may be true for council housing where there have recently been well-publicised problems with the current provider.

85/19 To receive reports from police representatives

No police representatives were present.

86/19 To receive reports from members.

Cllr Heren reported on an aggressive reaction from the Fordwich Arms to a car parked by a resident. He wondered if FUC should seek to restrict parking in the road outside the town hall.

The chairman reported that he had met with the Fordwich Arms' proprietors to discuss arrangements for the civic service. This was a positive meeting. A proposal as to cost was awaited. In addition, the Fordwich Arms have agreed to the May 8th street party and to helping with the Christmas tree.

The chairman also noted the successful road sweep by SERCO recently. Apparently they will do this on the first Monday of the month from now on.

A defibrillator in the phone box has been suggested. It remains to be seen how much support there is for this idea.

Clive Wren has resigned as tree warden. An advertisement for a replacement will be placed in the newsletter.

There will be an election on August 15th to fill the vacancy created by the resignation of Cllr Clark.

Cllr McCarthy will send details of road signs being blocked by vegetation to the clerk. He will also send pictures of the dangerous state of repair of the bridge. He noted that the pavement opposite the George and Dragon was in very poor condition. He noted water mains leaks in the Drove (soon to be repaired) and in Spring Lane. Southern Water will not replace water mains here as they claim they are private roads.
