102/16 To consider the application for a goods vehicle operator's licence at Moate Farm.

On August 4th a notice had been published of an application for an operator's licence at Moate Farm for "one vehicle, no trailer". After much discussion, it was unanimously resolved to object to this application on grounds including:

- No planning permission exists at this site for business use
- The local roads are unsuitable for heavy goods vehicles
- A residential environment is unsuited to goods vehicle operations
- The finances of the applying company, SE Driveways Ltd., appear to be inadequate to support such an application.

The clerk was duly requested to draft a letter along these lines to the Transport Commissioner with copies to the applicant's company and in person. The clerk was also requested to find out whether the 21 day deadline for objections could be extended and whether it was possible to se the full details of the application.

103/16 To receive reports from CCC and KCC representatives

Neither of the representatives had anything further to report.

104/16 To receive reports from police representatives

No police representative was present.

105/16 To receive the chairman and councillors' reports.

Cllr Clark suggested that our Flood Warden should receive the River Group email updates. The clerk said he didn't think he had an email address for the flood warden and would be pleased if someone could supply this.

It was reported that the George and Dragon and Canoe Wild are telling people (staff, in the case of the pub) to park in Brooklands Close. Clearly whilst not illegal, this is undesirable. Cllr McCarthy undertook to speak to a senior member of staff at the pub about this.
